# Inaugural Sailing 4 Parkinson's Regatta

April 12, 2026

## Notice of Race

### 1. RULES

- 1.1. The race will be governed by the rules as defined in *The Racing Rules of Sailing*. The Organizing Authority is the Corinthian Yacht Club of San Francisco.
- 1.2. RRS 40.1 will apply requiring competitors to wear Personal Flotation Devices.
- 1.3. One Design class rules are in effect where there is a One Design fleet formed.

### 2. ELIGIBILITY AND ENTRY

- 2.1. Entry is open to monohull keel boats and multihull boats over 25ft.
- 2.2. Eligible boats shall enter by completing the online entry form found on the Sailing4Parkinsons website at [sailing4parkinsons.org](http://sailing4parkinsons.org)
- 2.3. Only one entry per boat will be accepted.
- 2.4. All participating boats should have a valid 2026 NCPHRF or BAMA certificate. The race committee may, at its discretion, waive the ratings certificate and/or, assign ratings to boats provisionally or finally where (a) YRA has not delivered an applied-for rating or (b) racing one-design or (c) racing non-spinnaker.
- 2.5. Fleets will be defined based on entry registration and may include PHRF, Non-Spinnaker, One Design, and Multi-hull. A fleet with five or fewer boats may be merged with another fleet. Final fleet assignments will be set out in the sailing instructions;
  - **PHRF and BAMA fleets** will be grouped primarily based on their relevant assigned rating and hull characteristics.
  - **One Design fleets** may be formed when five or more entries of that class are registered.
  - **Non-Spinnaker Fleet** is for boats rated with spinnakers but racing without them, if accepted by the Race Committee. Boats listed on the *NCPHRF Base Rating Report* as **No NonSpin** are not eligible to register in the Non-Spinnaker fleet. All boats in the Non-Spinnaker divisions are subject to ratings modification by the Race Committees at its discretion.

### **3. FEES**

- 3.1. The entry fee for the entire regatta will be \$125 for each boat
- 3.2. Entries must be received before April 12, 2026
- 3.3. Entries submitted after April 10, 2026 may be permitted at the discretion of the race organizer.

### **4. SCHEDULE OF EVENTS**

- 4.1. One race is scheduled
- 4.2. First Warning Signal is scheduled at 1230hrs.

### **5. SAILING INSTRUCTIONS**

Sailing Instructions will be available prior to the start of the first race on the web site at: [sailing4parkinsons.org](http://sailing4parkinsons.org)

### **6. VENUE & COURSES**

The series will take place entirely within San Francisco Bay. Courses will be defined in the Sailing Instructions.

### **7. PENALTY SYSTEM**

Appendix T1 section A of *RRS* will apply and will be included in the SI's.

### **8. SCORING**

- 8.1. Handicapped divisions will be scored time-on-time or time-on-distance for handicapped timed (pursuit) starts.
- 8.2. The time limit for each race will be 16:45 hrs. Boats failing to finish before the time limit expires will be scored DNF without a hearing. This changes *RRS* 35,A4 and A5.

### **9. RADIO COMMUNICATIONS**

The Race Committee may make radio transmissions to communicate information about the start and recalls.

## **10.PRIZES**

- 10.1. Event awards will be presented at a celebration at the CYC Clubhouse following the race.

## **11.INSURANCE**

Each participating boat shall be insured with valid third-party insurance.
